The item listed as part of the Omnibus motion were all passed. These items included:

- 1. The COM approved Norlita Kaul to serve as a staff pastor at Germantown Presbyterian Church for ¾ time on a 12 month contract and to be allowed to administer the sacraments. (This covenant begins on Saturday, April 16, 2011 and it can be terminated prior to the twelve (12) months by either GPC or Norlita with sixty (60) days written notice.) The financial compensation is as follows:

2,754 SECA (7.65%)

7,020 Major Medical (19.5%)

4.320 Pension (12%)

900 Auto/travel allowance

2. The COM approved Norlita Kaul to take the PCUSA ordination exams in preparation for becoming a PCUSA pastor.

3. The COM approved the request from Balmoral PC to have the Rev. Stephanie Patton be approved to moderate the Session, to administer the Sacraments, to preach and provide pastoral care during the months of June, July, and August 2011, while Carla Meisterman is on sabbatical leave, and she will be paid \$10,500.

- 2. Names of elders present are not noted.
- Each meeting was not opened and closed with prayer.
 Session did not always approve its own minutes.
 Session did not meet at least once a quarter.

- 6. An audit of the church's books was not made.
- 7. Session did not approve annual budget of church.
- 8. Annual Statistical Report was not approved, included in minutes, and ordered to be forwarded to Presbytery.
- 9. Session did not make an annual review of the church membership roll to maintain an accurate roll of (a) active members, (b) inactive members, (c) baptized members, (d) affiliate members.
- 10. Communications from higher governing bodies were not read and acted on by the Session as requested by the sending higher governing body.
- 11. Minutes do not state the composition of the Session with regard to racial ethnic members, women, men, and age groups and how this corresponds to the composition of the congregation.
- 12. Session's minutes do not record the annual review of the adequacy of compensation for all staff.
- 13. Representatives were not elected to each meeting of Presbytery.
- 14. Representatives did not report to the Session on their attendance at Presbytery.
- 15. Minutes are not included of at least an annual congregational meeting.
- 16. Congregational meeting minutes do not record a "review of the adequacy of the compensation of the pastor or pastors."
- 17. The vote to call (and the business specified for) each congregational meeting was not recorded in Session's
- 18. Minutes are not included of all congregational meetings called by the Session.
- 19. Minutes of the Board of Deacons were not examined annually by the Session.
- 20. A Joint Board Meeting (if the church has a Board of Deacons) was not held.

- 21. Minutes do not record ordination and installation of new Deacons and Elders.
- 22. Minutes do not record reception of new members, giving full names, and noting manner of reception (Profession of Faith, Transfer by Letter, Reaffirmation).
- 23. All dismissals and other deletions from the church roll were not acted upon by the Session with full information recorded in the Minutes.
- 24. There are irregularities or inconsistencies with Presbyterian procedure in actions of the Session.

Report to the Presbytery of the Mid-South Chronology of Events First Presbyterian Church, Ripley, TN

- 1. A letter dated March 8, 2011 was sent by certified mail to the Stated Clerk of the Presbytery of the Mid-South, from Dan Irvin, Clerk of the Session of First Presbyterian Church, Ripley, TN, requesting dismissal with property from the PC(USA).
- 2. On February 12, 2011, the Mid-South Presbytery approved an Administrative Commission to work with churches seeking dismissal.
- 3. The Administrative Commission members met with the Session on April 5, 2011, and talked with the Elders about their concerns and desires.
- 4. The Administrative Commission met with the Congregation on April 5, 2011, and after making a presentation, a vote was taken. There were 13 people present and voting and the vote was 13~ for 0 against.
- 5. The Administrative Commission reports it has fulfilled the requirements in "Guidelines and Standards for Dismissing Congregations" to the best of its ability. It is with sadness that the Administrative Commission presents the following motion on its own merits:
- 6. Motion from the First Presbyterian Church, Ripley, TN, to be dismissed with its property from the Presbytery of the Mid-South of the Presbyterian Church (USA) to the Presbytery of the Central-South of the Evangelical Presbyterian Church, and by being dismissed with property, First Presbyterian Church, Ripley, TN, acknowledges that the Presbytery of Memphis, which is now called the Presbytery of the Mid-South of the Presbyterian Church (USA), no longer has any financial obligations or responsibilities in any way for this church and its property; and the effective date of this dismissal will be the date the Stated Clerk of the Presbytery of the Mid-South receives a confirmation letter of official acceptance by the Evangelical Presbyterian Church.
- 7. The First Presbyterian Church in Ripley, TN has agreed to pay its per capita on a declining basis as outlined in #7 of the dismissal document.

8. With the dismissal of this church, Conner Franklin will no longer be a PCUSA Commissioned Lay Pastor there.

Also included here are the Administrative Commission reports from each church. The entire report was moved and seconded. The floor was opened for further discussion. Rev. Linda Jo McKim presented the following substitute motion.

Whereas the EPC is not in correspondence with the PCUSA and whereas the actions taken by these churches and several others in the past is a violation of the Constitution of the Presbyterian Church USA, I move that the Presbytery of the Mid-South declare these churches to be in schism and that their pastoral staff be declared in violation of their ordination vow to promote the peace and unity of the church.

Whereas these churches are in schism and their pastors have violated their vows and the EPC is not in correspondence with the PCUSA, that no letter of dismissal be forthcoming from the Presbytery of the Mid-South,

Whereas the pastoral staff of these churches have violated their ordination vows they must repent of their treason or renounce the jurisdiction of the PCUSA at this meeting.

Following a motion and second and then discussion of the substitute motion, the assembly noted that they were ready to vote on whether or not the substitute motion should become the main motion. The assembly failed to support the substitute motion by a margin of 14 for and 55 against.

Discussion then returned to the main motion. The question was called and the motion passed by a vote of great strength. Time was then taken for silent prayer.

6. Rev. Carla Meisterman made the following motion: that Presbytery appoint a task force for Financial strategy made up of 5 people appointed by Presbytery Council. The Task Force will work with Phil Shannon, Treasurer and John Coats of the Endowment Committee to examine assets, liabilities, staff, ministry and mission in order to develop strategy and present options for assuring financial health for the future of our Presbytery. The motion was seconded, discussed and passed.

Lunch 12:15 p.m.

Small Groups

The Presbytery moved into a period of small group conversations at 1:00 p.m. Each group discussed the same questions. Highlights of things to do in the future included:

- 1. Build deeper relationship with each other.
- 2. Develop more learning opportunities.
- 3. Have more fellowship events.
- 4. Do more strategic planning.
- 5. Share good things happening in local churches.

All agreed this was a very helpful session.

Leadership Mission Area

The Committee on Ministry reported through Rev. Michael Krech the following:

Motion to sustain the examination of Tom Sauer and to recommend him to the Presbytery to become a Commissioned Lay Pastor and to be commissioned at the May 10 Presbytery meeting. Motion to commission Tom Sauer to serve as a CLP at the LaGrange Presbyterian Church and to lead worship, to moderate the Session, administer the Sacraments, and approve the terms of service for twelve months and he will be paid \$200 per service which included mileage reimbursement. The Rev. Roger Graf will be a mentor to Tom.

Both motions passed following a presentation and time of questioning of Tom Sauer. Tom was then commissioned as a lay pastor.

There was no report from Committee on Preparation for Ministry.

Bills and Overtures

Rev. Tom Pickering, chair, reported for the Bills and Overture Committee.

I. For Action. General Assembly Overture 10-2 *The Confession of Blhar* Motion:

That *The Book of Confessions* be amended by adding the Confession of Belhar following A Brief Statement of Faith – Presbyterian Church (USA) and its accompanying documents? The "Accompanying Letter" and scriptural references to the confession should be printed with it without confessional status if this proposal is adopted.

The Committee Recommends:

The committee moves this item and asks that it be considered on its merits without a recommendation of the committee. It does offer one piece of guidance. The General Assembly by requiring a 2/3 vote of all Presbytery recognizes that confessions should not be added to our Book of Confessions unless they make a

specific and compelling contribution. Whether or not the Confession of Belah meets that standard is up to the wisdom of each Presbyter as they are led by the Holy Spirit.

After discussion a vote was called. Those favoring Belhars addition to the Book of Confessions amounted to 28 votes. Those not favoring the addition amounted to 30 votes. The motion did not pass.

Tom then presented the second part of his report:

II For Action.

Recommendations of B&O concerning the effects of nFOG on the Presbytery and the Congregations of the Presbytery.

If nFOG is adopted by the Church as a whole, on July 11, 2011 major portions of the previous book of order that have guided us in the past will cease to exist, I called Greg Goodwiller of St. Andrew Presbytery to see what he was recommending for his presbytery. They have adopted a motion similar to motion #1 to provide a bridge until their manual of operations can be revised. Motion #2 is designed to provide a similar temporary bridge for our congregations while our congregations adapt to the changes brought if nFOG goes into effect on July 11th.

Motion 1:

In the event the New Form of Government passes and becomes effective July 11, 2011, where it is unclear or where items have not been updated in a revised Presbytery Manual of Operations, The Presbytery of the Midsouth adopts the 2009-2011 Form of Government as its standard.

After the motion was opened for discussion, Carla Miesterman offered a substitute motion that was seconded. The substitute motion said:

Presbytery appoints a Task Force for the Implementation of nFOG chaired by The Reverend Anne Apple, Adjunct Professor of PCUSA Polity at Memphis Theological Seminary. Presbytery Council will staff this Task Force with an additional 3 members no later than June 10, 2011 to accomplish the following:

- 1. Prepare an implementation plan for the new Form of Government to be presented at the August Presbytery meeting.
- Chair Anne Apple will work with the Presbytery office to communicate with all Clerks of Session in our Presbytery before June 1, 2011 to make sure sessions have adopted the appropriate quotas for session and congregational meetings before July 1, 2011 to insure the business of their churches may be conducted.
- 3. Task Force for Implementation will provide nFOG resource information to each session and encourage each session to name a person in their church to act as a parliamentarian for nFOG to work with the Task Force for Implementation during this transition.
- 4. Task Force for Implementation will call and equip a team of educators to prepare and schedule training for all pastors and sessions in our Presbytery of nFOG by December 2011.
- 5. Presbytery will name a Task Force for updating Presbytery By-Laws chaired by Honorable retired pastor, The Reverend Maggie Jorgensen, Attorney at Law. Council will staff this Task Force with an additional 3 members no later than June 10, 2011 to work in concert with the Task Force on Implementation of nFOG to insure that Presbytery by-laws and nFOG are working in concert by December 31, 2011.

Following a time of perfecting both the substitute motion and the main motion a vote was called for asking if the substitute motion should become the main motion. By a vote of 23 for and 30 against, the substitute motion failed to become the main motion. A vote on the main motion was then taken and it <u>passed</u> by a margin of 47-2.

Tom then presented another motion in regard to the possible passage of nFOG.

Motion 2:

In the event the New Form of Government passes and becomes effective July 11, 2011, the Presbytery of the Mid-South adopts the 2009-2011 Form of Government as the standard for the congregations in the Presbytery until a congregation has revised its own by laws to reflect the New Form of Government.

Following a brief discussion the motion passed by a vote of 48-0.

Tom ended his report with the following information:

For Information:

Bills and Overtures is developing a "boiler plate" set of Bi-Laws to provide guidance for our congregations which will reflect the changes that Churches will need to make in their bi-laws cover areas where nFOG is silent.

Coordinating Council

Dr. Steve Montgomery reported for the council and asked that:

- 1. Bo Scarboro be added to the standing Administrative Commission in regard to dismissals.
- 2. Stephanie Wall be added to the Administrative Commission for First Presbyterian Church in West Memphis, AR.

The Presbytery approved both appointments.

Nominating Committee

Carla Meisterman reported for Will Jones and asked churches to submit their nominations to the committee.

Conference Report
